Dear Friends,

To say we live in unprecedented times might be an overstatement. Certainly, the world is not in more turmoil than during the World Wars. And many of us remember living during the palpable tension of the Cold War. Yet now challenges come at us from all sides - division, within and without.

Besides the threats from Russia, China, and Iran, we have a rise in religious extremism in Israel and antisemitism and hate in America. Our country is divided between Red and Blue lines. It seems as though Lincoln's famous words, "A house divided against itself cannot stand," apply to us once more.

Amidst this background, we celebrate Passover. The great 20th-century Modern Orthodox luminary, Rabbi Joseph B. Soloveitchik, wrote:

History, Judaism says, cannot move or progress without the individual. God waits for man if there is something to be done. He does nothing until man initiates action. God waits for man, for a single person, to accept responsibility and initiate the process of ge'ulah, of redemption. It is strange. On the one hand, God is the Go'el Yisrael, our redeemer and liberator; however, God wills man to become His Shali'ah [his messenger or representative] in the drama of ge'ulah, the personalistic shali'ah with whom God will walk.

God wants an individual great in knowledge, in morality, in prophecy, to be a participant in the drama of ge'ulah. God wills man to emerge as a great being through his acceptance of the shelihut, mission. Not the collective, but the individual, seizes the initiative. "It came to pass in the course of those many days, that the king of Egypt died, and the children of Israel sighed by reason of the bondage and their cry rose up to God...and God saw their affliction, and God knew" (Exodus 2:23-25). God was ready, the people were ready, the time had passed, ge'ulah was possible, and God could have taken them out in a split second. But God had to wait for someone. Immediately, in the next verse, Moses is mentioned: "Now Moses kept the flock of Jethro" (Exodus 3:1).1

Likewise, in our day and age, we can't sit back and be passive. If we care about the future of America, Israel, and our planet, we need to be proactive. We each need to think about what we can do to be proponents of peace, defenders of the defenseless, and guarantors of freedom for all.

PASSOVER GUIDE

What follows is a general guideline of dietary regulations for Passover. This guide is for use by our congregants and is not intended to set standards for other communities. Any questions should be directed to the Rabbi, who would be happy to clarify any doubts.

Prohibited foods: Prohibited foods containing fermented or leavened grain that has been exposed to water for 18 minutes prior to cooking or baking. These foods are called *CHAMETZ*. Examples are breads, cake, crackers, cereal, cookies, pasta, candy, or any product containing grain derivatives such as flavors made with grain alcohol, grain vinegar, liquors, beer, etc. Ashkenazic tradition by which we are bound also prohibits the use of rice, corn, beans, and peas known as *Kitniyot*.

Permitted foods: The following foods do not require "Kosher for Passover" labels if purchased prior to Passover. Note labels must be checked to verify that these items are in their pure form with no additives unless otherwise specified: unflavored caffeinated coffee, tea, cane sugar, salt, whole unprocessed spices, frozen fruit juice no additives, fresh fruit juice, frozen fruit, milk, cream. The following products may also be purchased on Passover without a special Passover certification: fresh fruits, fresh vegetables, eggs, fresh fish, and fresh meat.

All other processed foods, including frozen vegetables and dried fruit require a special Kosher for Passover certification.

Detergents: Dishwashing detergents do not require a special "Kosher for Passover" labels, however, new containers should be used.

Medication: Discontinuing any medication, which you are taking at the advice of a doctor, is prohibited according to *Halacha*. If you are taking a medication that you suspect contains *CHAMETZ* please consult the Rabbi prior to discontinuing said medication. Many medications do contain *CHAMETZ* binders; the Rabbi is available to discuss any medical issues with both you and your doctor.

KASHERING OF KITCHEN APPLIANCES AND UTENSILS

Utensils and dishes: It is customary (and easiest) to remove the utensils and dishes that are used during the year, replacing them with either new utensils or utensils reserved for exclusive use on Passover. Most metal and hard plastic items can be koshered by dipping them in boiling water for 10 seconds. Certain non-stick utensils cannot be koshered. Ask the rabbi or see the RA guide.

Ovens and ranges: Every part that comes in contact with food must be thoroughly cleaned. This includes the walls and the top and bottom of the oven. The oven or range should then be heated at its highest possible temperature. The oven should be heated at maximum heat for at least an hour; the range top should be heated until the elements turn red and glow. The grates from range should be cleaned with a caustic (Easy Off type) cleanser. After a general and careful cleaning, a self-cleaning oven is put through a three hour cleaning.

Microwave ovens that have no convection option should be thoroughly cleaned. Then place an eight-ounce cup of water inside the oven and microwave until the water almost disappears. (At least 6 of the 8 ounces need to evaporate.) Do not heat until the water is completely evaporated, as this may damage the oven. A microwave/ convection or browning oven is kashered like regular ovens. When cleaning, be sure to thoroughly clean around the fan.

Dishwashers need to be cleaned as thoroughly as possible, including the inside area around the drainage and filters. Then run a full cycle with detergent (with racks inserted), while empty.

Metal kitchen sinks can be kashered by thoroughly cleaning and scrubbing the sink (especially the garbage catch), letting it sit for 24 hours, and then carefully pouring boiling water over all the surfaces of the sink, including the lip. A porcelain sink cannot be kashered, but should be thoroughly cleaned and used with Passover dish basins and dish drains, one each for dairy and for meat.

Refrigerators and freezers are cleaned using any household cleaner. For further information go to:
